By-Law #2011-01

Being a By-law to authorize signing authority on behalf of the Local Services Board of Nolalu.

WHEREAS Section 12 (2) of the *Northern Services Board Act*, R.S.O. 1990, CHAPTER L.28 provides that the Board shall by by-law authorize the secretary and one or more members of the Board to be signing officers on behalf of the Board;

NOW THEREFORE the Local Services Board of Nolalu enacts as follows:

1. THAT the Secretary/Treasurer and the Chairperson shall be signing officers on behalf of the Board for the purposes of, including but not limited to, by-laws, contracts, agreements, correspondence and audits.
2. THAT in the absence of the Chairperson, Larry Bockus or Lloyd Snider are authorized to sign on the Chairperson's behalf.
3. THAT Sharon Low, Larry Bockus and Lloyd Snider shall be signing authorities for the bank accounts held at the Provincial Alliance Credit Union Limited, Kakabeka Falls Branch; and

FURTHER THAT any two of these signatures shall be affixed to each cheque or journal voucher drawn upon the bank accounts.

4. THAT this by-law shall become effective as of October 1, 2011.
5. THAT all by-laws or parts of by-laws conflicting with this by-law are hereby repealed.

By-Law #2011-04

Being a by-law to set the tax levy for the 2011-2012 fiscal year and to authorize the Ministry of Revenue to collect the levy.

The Local Services Board of Nolalu enacts as follows:

1. THAT a flat rate of \$110.00 per eligible property shall be levied to meet the Board's expenditures for the 2011-2012 fiscal year, for a total revenue of \$71,500.
2. THAT the LSB of Nolalu hereby authorizes the Ministry of Revenue to collect \$71,500 on behalf of the LSB of Nolalu for the powers of fire protection, recreation and LSB administration.

Being a by-law to amend By-law #2009-01, being a by-law to establish a reserve for contingency use.

By-Law #2012-01

Being a by-law to set the tax levy for the 2011-2012 fiscal year and to authorize the Ministry of Finance to collect the levy and to repeal By-law #2011-04.

WHEREAS after the adoption of the 2011-2012 budget, it was discovered that 13 properties that were included on the interim assessment roll provided by MPAC, were not included on the assessment in OPTA; and

WHEREAS the Ministry of Finance requires that the by-law authorizing the Ministry to collect the levy, must agree to the information entered in OPTA.

NOW THEREFORE The Local Services Board of Nolulu enacts as follows:

1. THAT a flat rate of \$110.00 per eligible property shall be levied to meet the Board's expenditures for the 2011-2012 fiscal year, for a total revenue of \$70,180.
2. THAT the LSB of Nolulu hereby authorizes the Ministry of Revenue to collect \$70,180 on behalf of the LSB of Nolulu for the powers of fire protection, recreation and LSB administration.
3. THAT By-law #2011-04 is hereby repealed.
